AGRICULTURAL LEGISLATION (PENALTIES) AMENDMENT ACT

No. 20 of 1989

AN ACT to amend the penalty provisions in certain Acts.

[Assented to 1 December 1989]

The Parliament of Western Australia enacts as follows:

Short title

1. This Act may be cited as the *Agricultural Legislation (Penalties) Amendment Act 1989*.

Commencement

2. This Act shall come into operation on such day as is fixed by proclamation.

Various penalties amended
