AN ACT to amend the Skeleton Weed and Resistant Grain Insects (Eradication Funds) Act 1974.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:---

1. (1) This Act may be cited as the Skeleton short title Weed and Resistant Grain Insects (Eradication Act. Funds) Amendment Act 1985.
