AN ACT relating to certain reserves and other lands.

[Assented to 9 December 1982.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:----

This Act may be cited as the Reserves Act Short title. 1. (No. 2) 1982.

2. The purpose of Reserve No. 22576, classified Reserve No. 22576 at Class A containing 2 845 6 hectares set apart Kalamunda. as of Class A, containing 2.845 6 hectares, set apart for "Public Park and Protection of Natural Flora" and placed under the control of the Shire of Kalamunda, is hereby changed to "Park".

Reserve No. 14289 south east of Boyanup. 3. Reserve No. 14289, classified as of Class A, containing 168.3492 hectares, set apart for "Reafforestation" is hereby cancelled.

Reserve No. 31362 at Irwin Inlet.

4. Reserve No. 31362, classified as of Class A, containing 17 709.588 2 hectares or thereabouts, set apart for "National Park" and vested in the National Parks Authority of Western Australia, is hereby amended by excising an area of 39.133 2 hectares comprising Hay Locations 2233, 2234, 2235, and 2296.

Reserve No. 27004 at Kalbarri.

5. Reserve No. 27004, classified as of Class A, containing 186 076.182 8 hectares, set apart for "National Park" and vested in the National Parks Authority of Western Australia, is hereby amended by excising an area of 21.731 3 hectares comprising Victoria Location 11493.

Reserve No. 11681 at Gosnells. 6. Reserve No. 11681, classified as of Class A, containing 178.0617 hectares or thereabouts, set apart for "Parklands" and placed under the control of the City of Gosnells, is hereby amended by excising an area of 113.2388 hectares or thereabouts comprising portion of Canning Location 3343.

Reserve No. 6922 at Darlington. 8. Reserve No. 6922, classified as of Class A, containing 41.0070 hectares, set apart for "Public Park" and vested in the Shire of Mundaring, is hereby amended by excising an area of 6.0057 hectares comprising Greenmount Suburban Lot 556.

9. Reserve No. 29977, classified as of Class A, Reserve No. 29977 at containing 71.774 1 hectares, set apart for "Conservation of Flora and Fauna" and vested in the Western Australian Wildlife Authority, is hereby amended by excising an area of 7.2118 hectares shown coloured dark brown on Lands and Surveys Original Plan 15428 and contained in the reserve.

10. Reserve No. 30082, classified as of Class A, Reserve No. 30082 in Hamersley Range. containing 617 606 hectares or thereabouts, set apart for "National Park" and vested in the National Parks Authority of Western Australia, is hereby amended by excising an area of 400 hectares or thereabouts shown as the proposed national highway alignment on Main Roads Department Drawing "Proposed National Highway Route Through Hamersley Range National Park" 8224-80 and contained in the reserve.

Reserve No. 21054, classified as of Class A, No. 21054 at part for "Disused Less Perth." 11. containing 4.452 2 hectares, set apart for "Disused Burial Ground" and vested in the National Parks Authority of Western Australia, is hereby amended by excising an area of 172 square metres comprising Perth Lot E113.

Reserve No. 11710, classified as of Class A, Reserve no. 11710 at containing 9 079.118 4 hectares or thereabouts, set Lake Preston. apart for "National Park" and vested in the National Parks Authority of Western Australia, is hereby amended by including an area of 276.7707 hectares comprising Wellington Location 5334.

Reserve No. 27575, classified as of Class A, $\frac{\text{Reserve}}{\text{No. 27575 at}}$ containing 1 026.106 6 hectares, set apart for $\frac{\text{Quinns}}{\text{Rocks.}}$ "National Park" and vested in the National Parks Authority of Western Australia, is hereby amended by including an area of 64.026 2 hectares comprising Swan Location 10313.

Reserves Nos. 29713 and 29715 east of Ravensthorpe. 14. (1) Reserve No. 29713, classified as of Class A, containing 2 046.015 5 hectares, set apart for "Stopping Place" is hereby amended by excising an area of 68.009 4 hectares comprising Oldfield Location 1364.

(2) The Governor may grant the land comprising Oldfield Location 1364 for an estate in fee simple to the registered proprietor of Oldfield Location 995 in exchange for an area of 72.859 hectares comprising Oldfield Location 1365.

(3) Upon transfer to the Crown of Oldfield Location 1365 referred to in subsection (2) of this section, that land is revested in Her Majesty as of Her former estate and is removed from the operation of the Transfer of Land Act 1893 and the land comprising Oldfield Location 1365 shall thereupon, by operation of this subsection, be included in Reserve No. 29715, classified as of Class A, set apart for "Parklands".

Reserve No. 20956 at Bayswater.

15. Reserve No. 20956, classified as of Class A, containing 1.2348 hectares, set apart for "Recreation" and vested in the Shire of Bayswater, is hereby cancelled.

Reserve No. 13375 at East Perth. 16. Reserve No. 13375, classified as of Class A, containing 7.7879 hectares, set apart for "Roads, Park and Public Recreation" and portion vested in the City of Perth, is hereby amended by excising an area of 2 580 square metres comprising Perth Lot 947.
