No. 13 of 1981.

AN ACT to amend the Constitution Acts Amendment Act 1899-1980 and the Electoral Districts Act 1947-1975.

[Assented to 22 May 1981.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Acts Amendment Short title. (Electoral Provinces and Districts) Act 1981.

PART I—CONSTITUTION ACTS AMENDMENT ACT 1899-1980.

2. (1) In this Part the Constitution Acts Citation. Amendment Act 1899-1980 is referred to as the principal Act.

 - (b) 2 electoral provinces, one consisting of the electoral districts of Gascoyne and Murchison-Eyre as referred to in paragraph (a) of this subsection and the other consisting of the electoral

districts of Kimberley and Pilbara as determined in accordance with that paragraph. ".

 - (a) there shall be 7 electoral provinces in the Metropolitan Area as referred to in section 4 of this Act, each of which shall consist of 4 or 5 complete and contiguous electoral districts contained in that area;
 - (b) there shall be 8 electoral provinces in the Agricultural, Mining and Pastoral Area referred to in section 4 of this Act, each of which shall—
 - (i) consist, as far as possible, of 2 or 3 complete and contiguous electoral districts contained in that area; and

- (ii) contain, to the extent considered practicable by the Commissioners, approximately the same area as it contained immediately prior to that date; and
- (c) each of the 2 electoral provinces in the North-West-Murchison-Eyre Area as referred to in section 4 of this Act shall consist of 2 complete and contiguous electoral districts contained in the North-West-Murchison-Eyre Area in accordance with paragraph (b) of subsection (2) of section 7 of this Act. "

All that portion of land bounded by lines starting from the intersection of the centre line of Gnangara Road with the prolongation easterly of the easternmost northern boundary of the north-western severance of Swan Location 2288, a point on a northern boundary of the area described in Part 1 of this Schedule and extending westerly to and along that boundary to the prolongation southerly of the easternmost eastern boundary of the southern severance of Location 1826; thence northerly to and northerly, westerly and again northerly along boundaries of that severance and onwards to the centre line of Badgerup Road; thence north-easterly, generally northerly and again north-easterly along that centre line to the prolongation southerly of the centre line of Hawkins Road; thence northerly to and along that centre line to the prolongation easterly of the centre line of Trichet Road; thence westerly to and westerly, south-westerly and again westerly along that centre line to the centre line of Franklin Road; thence northerly along that centre line to the prolongation easterly of the centre line of Caporn Street; thence westerly to and along that centre line and onwards to the centre line of Pinjar Road; thence northeasterly and generally northerly along that centre line to the prolongation north-easterly of the centre line of Clarkson Avenue; thence south-westerly to and along that centre line and onwards to the centre line of Wanneroo Road; thence generally north-westerly along that centre line to the prolongation north-easterly of the centre line of Burns Beach Road; thence southwesterly to and generally south-westerly along that centre line to the easternmost north-eastern boundary of Reserve 11630; thence north-westerly and southwesterly along boundaries of that Reserve and onwards to the low water mark of the Indian Ocean, thence generally south-easterly along that mark to the prolongation westerly of the southern boundary of Lot M1722 of Location 1370, a point on a northern boundary of the area described in Part 1 of this Schedule and thence easterly, generally south-easterly and generally easterly along boundaries of that area to the starting point.

Part 3.

All that portion of land bounded by lines starting from the intersection of the prolongation southerly of the eastern boundary of Swan Location 5199 with a southwestern boundary of part of Lot 98 of Location 1315 as shown on Land Titles Office Diagram 55514, a point on an eastern boundary of the area described in Part 1 of this Schedule and extending generally southeasterly along boundaries of that part lot to the western corner of part Lot 99 as shown on Land Titles Office Diagram 55514; thence south-easterly along the southwestern boundary of that part lot to its southern corner; thence south-easterly to the western corner of part Lot 3 as shown on Land Titles Office Diagram 55514; thence south-easterly along the south-western boundary of that part lot to its southern corner; thence southeasterly to the westernmost south-western corner of the north-western severance of Lot 23 of Locations H, I, K and 1315 as shown on Land Titles Office Plan 12769; thence south-easterly along the south-western boundary of that severance and onwards to the westernmost north-western corner of the southern severance of Lot 23; thence generally south-easterly along boundaries of that lot and onwards to the centre line of Marshall Road, a point on a northern boundary of the area described in Part 1 of this Schedule and thence generally westerly, northerly, westerly and again northerly along boundaries of that area to the starting point.

Part 4.

All that portion of land bounded by lines starting from the intersection of the centre line of the Perth-Armadale Railway Reserve with the prolongation southwesterly of the centre line of Mountain View Avenue, a point on an eastern boundary of the area described in Part 1 of this Schedule and extending north-easterly along that prolongation to the centre line of Albany Highway; thence generally southerly and generally south-easterly along that centre line to the prolongation north-easterly of the centre line of South Western Highway; thence south-westerly to and generally southwesterly and generally southerly along that centre line to the prolongation easterly of the centre line of the eastern section of Eleventh Road; thence westerly to and along that centre line and onwards to the prolongation south-easterly of the centre line of the western section of Eleventh Road; thence north-westerly to and generally north-westerly along that centre line to the centre line of Forrest Road, a point on a southern boundary of the area described in Part 1 of this Schedule and thence generally north-easterly and generally northerly along boundaries of that area to the starting point.
