AN ACT to amend the Workers' Compensation Supplementation Fund Act 1980-1982.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Workers' and citation. Compensation Supplementation Fund Amendment Act 1982.

(2) In this Act the Workers' Compensation Supplementation Fund Act 1980-1982 is referred to as the principal Act.
