AN ACT to amend the Family Court Act 1975-1979.

[Assented to 4 December 1981.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the Family Court Short title Amendment Act 1981.

(2) In this Act the Family Court Act 1975-1979 Reprinted as approved 17 March 1980. is referred to as the principal Act.

(3) The principal Act as amended by this Act may be cited as the Family Court Act 1975-1981.

2. This Act shall come into operation on a date $\frac{\text{Commencement.}}{\text{ment.}}$ to be fixed by proclamation.
