(CONSEQUENTIAL
PROVISIONS).**

AN ACT to amend the Stamp Act, 1921-1977, the Money Lenders Act, 1912-1974, and the Companies (Co-operative) Act, 1943-1976.

[Assented to 7th November, 1979.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the *Credit Unions (Consequential Provisions) Act, 1979.* Short title.

2. This Act shall come into operation on the date on which the Credit Unions Act, 1979 comes into operation. Commence-
