

RESERVES.

No. 46 of 1979.

AN ACT relating to certain reserves and other lands.

[Assented to 7th November, 1979.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the *Reserves Act*, Short title.

2. (1) Reserve No. 12553, classified as of Class A, Reserve No. 12553 near Balingup. containing 173.205 5 hectares or thereabouts, and set apart for "Reafforestation", is hereby cancelled.

(2) The land heretofore comprising that reserve shall be included in State Forest No. 29.

3. (1) Reserve No. 23251, classified as of Class A, comprising Swan Locations 5325 and 5326, containing 61.158 1 hectares, set apart for "Recreation" is hereby amended by excising an area of 21.477 1 hectares surveyed as, and comprising, portion of Swan Location 9752.

(2) The land excised by the operation of subsection (1) of this section shall be reserved again for the purpose "Controlled Access Road".

8. (1) Reserve No. 2994, classified as of Class A, containing 7.7472 hectares, set apart for "Park Lands", is hereby cancelled.

(3) The land heretofore comprising those reserves shall be included in Reserve No. 7537, classified as of Class A, set apart for "National Park and Native Game".

9. (1) Reserve No. 25555, classified as of Class A, containing 2 064.3445 hectares, set apart for "Conservation of Flora and Fauna" and vested in the Western Australian Wildlife Authority is hereby amended by excising an area containing 25.3306 hectares surveyed as Wickpin AA Lot 513.
