BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Acts Amendment Short title. (Judicial Salaries and Pensions) Act, 1975.

2. This Act shall be deemed to have come into Commenceoperation on the eighth day of August, 1975.
