PERTH MEDICAL CENTRE.

No. 72 of 1973.

AN ACT to amend the Perth Medical Centre Act, 1966.

[Assented to 6th December, 1973.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

- 1. (1) This Act may be cited as the Perth short title Medical Centre Act Amendment Act, 1973.
- (2) In this Act the Perth Medical Centre Act, 1966, is referred to as the principal Act.
- (3) The principal Act as amended by this Act may be cited as the Perth Medical Centre Act, 1966-1973.

Amendment to section 12. (Delegation.) 2. Subsection (1) of section 12 of the principal Act is amended by adding after the word "members" in line three the words "or a committee of members and other persons".

Section 13A added. 3. The principal Act is amended by adding after section 13 a section as follows—

Additional land for Perth Medical Centre reserve.

- 13A. (1) The Governor may, on the recommendation of the Trust, by Order in Council published in the *Gazette* reserve for the purposes of the medical centre being established on the reserve any land specified in the Order in Council being land which has, from time to time, been acquired whether by purchase or otherwise, by the Trust.
- (2) On the publication of the Order in Council in the *Gazette* the land specified in the Order shall be—
 - (a) revested in Her Majesty as of Her former estate;
 - (b) removed from the operation of the Transfer of Land Act, 1893;

Cf. S. 31 (1) Act No. 37 of 1933. (c) included in and form part of the reserve and shall remain dedicated to the purpose for which it was so reserved, until by an Act it is otherwise enacted.

Amendment to the Schedule to the Act.

- 4. (1) The Schedule to the principal Act is amended—
 - (a) by substituting for paragraph 2 of Part I a paragraph as follows—
 - 2. Portion of Swan Location 1715, being the whole of the land comprised in Certificate of Title, Volume 1109 Folio 771 less the land comprised in Swan Locations 8697, 8698 and 8699.; and

(b) by substituting for Part II a Part as follows—

PART II.

Portion of Swan Location 1715 being the land comprised in Swan Locations 8697, 8698 and 8699 being the balance of the land comprised in Certificate of Title Volume 1109 Folio 771.

(2) It is hereby declared that this section shall operate and take effect and shall be deemed to have operated and to have had effect on and from the twelfth day of September, 1968; and such acts, matters and things as are necessary to be done to give effect to this subsection are hereby authorized to be done.
