RESERVES.

No. 105 of 1969.

AN ACT relating to certain Reserves and other Lands.

[Assented to 25th November, 1969.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and the Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:—

- 1. This Act may be cited as the Reserves Act, Short title. 1969.
- (1) Reserve No. 9914 at Broome, comprising Reserve No. 9914 at Broome Lot 136, containing two roods sixteen Broome. perches, classified as of Class "A", set apart for the purpose of "Mechanics Institute", and held in trust

for the purposes of a Literary Institute by the Mayor and Councillors of Broome under Lease No. 402/42 granted under the Land Act, 1898 for a term of nine hundred and ninety-nine years is reclassified as of Class "C" with the intention that the Governor may set apart separate reserves or otherwise dispose of any portion in accordance with the provisions of the Land Act. 1933.

(2) Lease No. 402/42 granted under the Land Act, 1898 is cancelled.

Reserve No. 12636 at Anglesea Island Bunbury.

- 3. (1) Reserve No. 12636 at Bunbury containing about twelve acres, classified as of Class "A", set apart for the purpose of "Recreation", and vested in the Bunbury Town Council is amended by excising an area of approximately eight acres from Anglesea Island to be surveyed as Bunbury Lot 505, as shown on Lands and Surveys Plans Bunbury Sheets 1 and 2.
- (2) The land excised by the operation of subsection (1) of this section shall be reserved for the purpose of "Bunbury Harbour Extensions" with the intention that it be vested in the Bunbury Port Authority.

Reserve No. 15927 at Bunbury.

- 4. (1) Reserve No. 15927 at Bunbury, comprising Bunbury Lot 380, containing about twelve acres, classified as of Class "A", set apart for the purpose of "Recreation", and under the control of the Town of Bunbury as a Board of Management appointed under the Parks and Reserves Act, 1895 is amended by excising that portion of the reserve containing about two and three tenths perches that is contiguous to Lot 361 on Lands and Surveys Plan CD No. 64 and that is included in the area shown coloured green on that plan.
- (2) The Governor is authorised to lease the land excised by the operation of subsection (1) of this section to the Bunbury Yacht Club Incorporated of Bunbury.

- (3) The purpose of Reserve No. 15927, as amended by subsection (1) of this section, is altered to "Recreation and Parking" and the authority of the Town of Bunbury as a Board of Management under the Parks and Reserves Act, 1895 is cancelled with the intention that the land remaining in the reserve be vested in the Town of Bunbury, for that purpose, with power to lease for any period not exceeding twenty-one years.
- The purpose of Reserve No. 25337 at Denmark, Reserve No. 25337 at comprising Denmark Lot 933, classified as of Class Denmark. "A", and vested in the Shire of Denmark, is altered from "Park (Pioneer Park) and Kindergarten Site" to "Park (Pioneer Park), Kindergarten and Bov Scouts Hall Site".

(1) Reserve No. 25141, at Flinders Bay comprising Sussex Locations 4125, 4126 and 4127, containing one hundred and eighteen acres one rood thirteen perches, classified as of Class "A", set apart for the purpose of "Recreation", and vested in the Augusta-Margaret River Shire Council is amended by excising an area of sixty-eight perches, surveyed as Augusta Lot 476, as shown on Lands and Surveys Plan 440 A/40 shaded pink.

Reserve No. 25141 at Flinders Bay.

- (2) The land excised by the operation of subsection (1) of this section shall be included in Class "A" Reserve No. 24653, which is vested in the Augusta-Margaret River Shire Council for the purpose of "Recreation and Camping".
- 7. (1) Reserve No. 22429, comprising Peel Estate Reserve No. Lots 284, 285 and 286, containing one hundred and Peel Estate Rockingham. twenty-five acres and thirty-four perches classified as of Class "A", and set apart for the purpose of "Recreation and Park land" is amended by excising an area of one-half an acre to be surveyed as Peel Estate Lot 1315, as shown on Lands and Surveys Plan 341 D/40 shaded pink.

(2) The land excised by the operation of subsection (1) of this section shall be reserved as a "Pound Site" with the intention that the reserve be vested in the Shire of Rockingham.

Reserve No. 997 at Lake Clifton.

- 8. (1) Reserve No. 997, at Lake Clifton, comprising Wellington Location 4631, containing forty-eight acres and twenty-four perches, classified as of Class "A", set apart for the purpose of "Camping and Recreation", and vested in the National Parks Board of Western Australia, is cancelled.
- (2) The land available from the reserve that is cancelled by the operation of subsection (1) of this section shall be included in the Yalgorup National Park Reserve No. 11710, which is classified as of Class "A" and set apart for the purpose of "National Park".

Reserve No. 4379 at Malcolm.

- 9. (1) Reserve No. 4379, Malcolm, containing two hundred and seventy acres, classified as of Class "A", set apart for the purpose of "Racecourse", and held in trust for that purpose, under Certificate of Title Volume 204 Folio 139, for a term of ninety-nine years, registered in the names of Peter Hill, Joseph George Walsh, and Francis Gillett Brewer, as Trustees of the Malcolm Racing Club, is cancelled.
- (2) The land available from the reserve that is cancelled by the operation of subsection (1) of this section is revested in Her Majesty, as of her former estate, and is removed from the operation of the Transfer of Land Act, 1893, with the intention that it be included in Reserve No. 7521, for the purpose of "Commons", and under the control of the Leonora Shire Council.

Reserve No. 24689 at Ravensthorpe. 10. (1) Reserve No. 24689, comprising Ravensthorpe Lots 702, 703 and 704, containing five acres two roods twenty-six perches, classified as of Class "A", set apart for the purpose of "Camping", and vested in the Ravensthorpe Shire Council, is cancelled.

- (2) The land available from the reserve that is cancelled by the operation of subsection (1) of this section may be reserved again for the purpose of recreation as the Governor may approve and vested in the Ravensthorpe Shire Council.
- 11. The purpose of Reserve No. 1313 comprising Reserve No. Avon Location 192, classified as of Class "A", and Totadgin Rock vested in the Minister for Water Supply, is altered Merredin. from "Water and Stopping Place" to "Water and Conservation of Flora and Fauna".

12. (1) Reserve No. 27107 containing thousand, three hundred and thirty-five acres, classified as of Class "A", and set apart for the purpose of "Townsite Extension (Albany) and National Park" is amended by excising an area of one half acre near Herald Point to be described by aerial photographs as Plantagenet Location 7135 and bordered green on Lands and Surveys Plan 457 B/40.

five Reserve No. 27107 at Albany.

- (2) The Governor is authorised to grant a lease of the land excised by the operation of subsection (1) of this section to Herbert Ronald Casey of Albany, Fisherman and Denys John Davies of Albany, Fisherman for a "Commercial Fishing Station".
- 13. (1) Reserve No. 29151, comprising Victoria Reserve No. 29151 at Location 10972, containing about fourteen acres two Horrocks Beach roods, classified as of Class "A", and set apart for the Angelon. purpose of "Camping and Public Recreation" is amended by excising an area of about two acres one rood twenty-five perches that is contiguous to Mitchell Street, Horrocks Street, and Reserve No. 29152.

(2) The land excised by the operation of subsection (1) of this section shall be included in Reserve 29152, Victoria Location 10994, a reserve set apart for the purpose of "Caravan Park" and vested in the Shire of Northampton with power to lease the whole or portion for any term not exceeding twenty-one years.

Reserve No. 27956 at Two Peoples Bay.

- 14. (1) Reserve No. 27956, comprising Plantagenet Locations 6744, 5409, 7065, 5394, 3985, 5368, 7068, 7069, 7070, 7066, containing eleven thousand four hundred and sixty acres, classified as of Class "A", set apart for the purpose of "Conservation of Fauna—Noisy Scrub Bird", and vested in the "Fauna Protection Advisory Committee" is amended by excising an area of approximately six-tenths of an acre to be described by aerial photographs as Plantagenet Location 7132 and bordered green on Lands and Surveys Plan 451 C/40.
- (2) The Governor is authorised to grant a lease of the land excised by the operation of subsection (1) of this section to Charles William Wilson of Lower King Albany, Fisherman and Lilian Jean Wilson of Lower King Albany, Married Woman for a "Commercial Fishing Station".

Reserve No. 21534 at Cranbrook.

- 15. (1) Reserve No. 21534 at Cranbrook, comprising Plantagenet Location 4855, containing seventynine acres and twelve perches, classified as of Class "A", set apart for "Agricultural Show Grounds", and held by the Cranbrook and District Agricultural Society Incorporated under a Crown Grant specified in Certificate of Title Volume 1047 Folio 710 registered in the name of the trustees Francis Eric Hitchins and John Thomas Newton is cancelled.
- (2) The land available from the reserve that is cancelled by the operation of subsection (1) of this section is revested in Her Majesty, as of her former estate, and is removed from the operation of the Transfer of Land Act, 1893, with the intention that the land be reserved again as of Class "A" and that the reserve be vested in the Shire of Cranbrook for the purpose of "Recreation".

16. The purpose of Class "A" Reserve No. 7535, Reserve No. 7535 at near Katanning, and vested in the Western Aus-Katanning. tralian Wildlife Authority, is altered from "Conservation of Indigenous Flora" to "Conservation of Fauna and Flora".

17. The Trustees for the time being of the Reserve No. Fremantle Public Cemetery Reserve No. 6066 Fremantle. classified as of Class "A" are authorised to lease to the Australian Wool Bureau established by the Wool Use Promotion Act, 1953, of the Parliament of The Commonwealth, for a period expiring on the thirtyfirst day of December, one thousand nine hundred eighty-nine, portion of Cockburn Sound Location 514, containing 27 acres 3 roods 7 perches, bounded by lines starting at the intersection of the eastern side of Carrington Street and the southern side of High Road and extending easterly along that side to the eastern boundary of the Location 514; thence southerly along that boundary for a distance of 7 chains 22 and 7/10ths links; thence westerly through the location and parallel to the southern side of High Road to the eastern side of Carrington Street and thence northerly along that side to the starting point, being part of the land comprised in Certificate of Title Volume 186 Folio 78.

18. (1) That portion of Reserve No. 12083 at Reserve No. 12083 at Reserve No. South Kalamunda, classified as of Class "A" and set South Kalamunda. apart for the purpose of a Public Education Endowment, and held in fee simple by the Trustees of the Public Education Endowment, comprised in Certificates of Title Volume 120 Folio 142A and Volume 1317 Folio 161, is amended by excising Kalamunda Lots 111 being Lot 2 on diagram 36080, 112, 113, 114 and 115 containing twenty-seven acres and thirty-seven and seven-tenths perches.

(2) The land excised by the operation of subsection (1) of this section is revested in Her Majesty, as of her former estate, and is removed from the operation of the Transfer of Land Act, 1893, with the intention that it be reserved for the purpose of "Schoolsite" under the provisions of the Land Act, 1933.
